Computershare Hong Kong Investor Services Limited, the Company's branch share registrar in Hong Kong, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

As at the date of the AGM, the Company had 5,885,000,000 shares in issue. The total number of shares held by the Shareholders entitled to attend and vote for or against all the ordinary resolutions was 5,885,000,000 shares. There were no shares entitling the Directors to attend and abstain from voting in favour at the AGM as set out in rule 13.4 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No shareholders of the Company were required under the Listing Rules to abstain from voting on the resolutions at the AGM. None of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on any of the resolutions at the AGM.
