ADJUSTMENT OF CONVERSION PRICE OF US\$320,000,000
5.0% CONVERTIBLE BONDS DUE 2022

In accordance with the CB Terms and Conditions, as a result of the declaration of the Dividends by the Company, the Conversion Price will be adjusted from HK\$7.71 per Share to HK\$7.53 per Share with effect from 12 June 2018, being the business day immediately after the record date i.e. 11 June 2018, in connection with such declaration.

Reference is made to the announcement (the “**Placing Announcement**”) of China Hongqiao Group Limited (the “**Company**”) dated 15 August 2017 in relation to, among other things, the issue of the US\$320,000,000 5.0% convertible bonds due 2022 (the “**Convertible Bonds**”) by the Company, and the announcement of adjustment of conversion price of convertible bonds dated 7 February 2018, and the poll results announcement of the Company for the annual general meeting of the Company dated 16 May 2018 (the “**Poll Results Announcement**”), and the Company paid a dividend for 2017 of the Company on 29 June 2018. Capitalised terms used herein have the same meaning as those defined in the Placing Announcement, unless otherwise defined herein.

ADJUSTMENT OF THE CONVERSION PRICE RELATING TO THE CONVERTIBLE BONDS

The terms and conditions of the Convertible Bonds (the “**CB Terms and Conditions**”) provided, among other things, that if the Company pays or makes any Capital Distribution (as defined in the CB Terms and Conditions) to the shareholders of the Company (the “**Shareholders**”), the Conversion Price shall be adjusted by multiplying the Conversion Price in force immediately before such Capital Distribution by the following fraction:

$$\frac{A-B}{A}$$

Where:

A is the Current Market Price (as defined in the CB Terms and Conditions) of one Share on the date on which the Capital Distribution is publicly announced, i.e. 16 May 2018 on which the Shareholders approved the declaration of the Dividends (as defined below); and

B is the Fair Market Value (as defined in the CB Terms and Conditions) on the date of such announcement of the portion of the Capital Distribution attributable to one Share.

Such adjustment shall become effective on the date that such Capital Distribution is actually made or if a record date is fixed therefor, the business day immediately after such record date.

As announced in the Poll Results Announcement, the board of directors (the “**Board**”) of the Company paid a final dividend of HK20.0 cents per Share for the year ended 31 December 2017 (the “**Dividends**”) to the Shareholders whose names appear on the register of members of the Company at the close of business on Monday, 11 June 2018. Pursuant to the CB Terms and Conditions, the Dividends fall within the definition of Capital Distribution. Accordingly, the Conversion Price per Share will be adjusted from HK\$7.71 to HK\$7.53 effective from 12 June 2018 (Hong Kong time), being the business day immediately after the record date i.e. 11 June 2018, in connection with the declaration of the Dividends (the “**Adjustment**”). Apart from the Adjustment, there is no change in the CB Terms and Conditions.

As at the date of this announcement, the total number of the issued shares of the Company is 8,765,071,849 Shares. Following the Adjustment, the number of Conversion Shares issuable by the Company upon full conversion of the outstanding Convertible Bonds will increase by 5,814,871 Shares and the maximum number of Conversion Shares to be issued by the Company upon full conversion of the outstanding Convertible Bonds will become 255,928,775 Shares. Such Conversion Shares will be issued and allotted pursuant to the general mandate granted by the Shareholders to the Directors in the adjourned annual general meeting of the Company held on 16 May 2018.
